

REGULATIONS OF PARTICIPATION

8th Development Initiation Forum

§1

General provisions

1. The organizer of the event: "8 Forum Development Initiation", hereinafter referred to as "FIR" or/and "Forum" is the Foundation for Initiating Development "UP Foundation" with headquarters in Gdansk, ul. Jaškowa Dolina 9/4, 80-252 Gdańsk, NIP: 9571059793, hereinafter referred to as the "Organizer".
2. The forum takes place on October 29, 2019, at the Hevelianum Center in Gdańsk, at Gradowa 6 and accompanying facilities hereinafter referred to as the "Forum Area".
3. Participation in the Forum for people who have been qualified by the Organizer to participate will be free, subject to §2, item 2-9.
4. Forum participants cover their own costs of travel to the venue, fees parking and return costs, as well as the cost of any overnight stay.
5. The number of places on the Forum is limited.
6. The participant may choose only one of the nine available workshops/discussions.
7. Participation in the Forum means reading the Regulations and accepting its terms.
8. Persons staying in the Forum are hereinafter referred to as "Participants". Participant - natural persons who are at least 18 years old and have full legal capacity, legal persons and organizational units without legal personality, but who may acquire rights and incur obligations on their own behalf, which the System uses correctly have registered on the Forum until the date indicated on the registration service.
9. The Regulations are addressed to every person staying at FIR during its duration. Persons staying in the Forum during its duration are obliged to be absolute comply with the provisions contained therein. Each Participant is obliged to behave in a way that does not endanger the safety of other participants, and in particular comply with provisions of FIR Regulations, facility regulations, and legal provisions, as well as comply with Organizer's instructions.
10. The purpose of the Regulations is to ensure FIR security by defining rules of conduct
11. Participants regulate their rights and obligations as well as organizational principles.
12. By "Registration" should be understood as the Organizer's consent to participate in FIR. Positively past registration entitles you to enter the Forum Area.
13. Identity cards should be understood as an ID card, passport, driving license, and ID card student, a document confirming the identity of a foreigner or another confirmation document identity provided with the face image and address of residence of the person using it.

§2

TERMS OF PARTICIPATION

1. Registration of participation in the Forum lasts from October 3, 2019, until the pool of places is exhausted but no longer than until October 25, 2019.
2. Registration of participation takes place only online via the form application available on the official website (System).
3. The official website of the Forum can be found at: <https://fir2019.konfeo.com/pl/groups>
4. The scope of the System's operation includes the service of storing registration in the database User, as well as handling this registration by the Organizer.
5. In order to register correctly in the System, the Participant is obliged to complete all indicated flap.
6. The user guarantees that all data provided for registration is correct.
7. By completing the registration, the Participant submits a declaration of reading and accepting the content of this.
8. Of the Regulations and consents to the processing of personal data for purposes related to implementation event.
9. After completing and confirming the accuracy of the data in the registration form to the one provided in it an e-mail address will be sent confirming receipt of the notification participation in the Forum.
10. Participants are obliged to pay a PLN 30 deposit to the Organizer. IN if it is not paid, it is not possible to register and participate in the Forum.
11. The deposit is fully refundable without interest within 14 days of the end of the Conference at the bank account indicated by the Participant.
12. The deposit referred to in para. 9 of the Regulations is not refundable if the Participant does not will attend in the Conference, subject to registration
13. Confirmation of participation in the Forum and a condition for returning the deposit is signing on the list presence available at the reception of the Conference.
14. The payment in the form of a deposit for participation in the Conference should be made through the Przelewy24.pl system along with completing the Application Form.
15. The organizer reserves the right to refuse entry to the Forum Area to the person:
 - a) under the influence of alcohol, intoxicants, psychotropics or other similar measures,
 - b) a person possessing a weapon or other dangerous objects, explosives, products pyrotechnics, fire hazardous materials, narcotic drugs or psychotropic substances,
 - c) a person behaving aggressively, provocatively or otherwise posing a threat to security or public order,
 - d) not on the registration list,
16. The Organizer will assess the items and classify them as dangerous.
